- ¹ For out-of-state License-to-Carry fingerprint requests, the PSP will fingerprint only if the request requires law enforcement to process the applicant and the individual resides in a PSP service area.
- ² Newly convicted sexual offenders will generally be registered and fingerprinted by the Office of Probation and Parole in the county of conviction; however, the PSP will provide fingerprint services to newly registered out-of-state offenders, offenders convicted under federal statute or the Uniform Code of Military Justice, and/or initial registrations in the event the county official is unable to process a new sexual offender as a result of equipment failure. The PSP will also fingerprint current registrants where it is determined palm prints are required.
