**Crash Synopsis:**

On 01/11/22 at approx. 1803hrs, PSP Clarion was dispatched to a single vehicle crash on Route 861 West of Hawk Hill Rd. in Madison Twp. Clarion County, PA. The crash occurred as Unit was traveling West and traveled across the East Bound Ln. Unit 1 then struck the embankment at the 10:00 position and rode along it for approx. 100 feet before striking a large boulder that was protruding from the embankment. The vehicle sustained disabling damage, and the operator was transported via ambulance for injuries of unknown severity. Assisted at the scene by Rimersburg Fire, Southern Clarion County Ambulance, New Bethlehem Police Dept., and Cornmans Towing.
