| 8. INCIDENT DETAILS This incident occurred as the Accused had requested for the Victim to arrive at his residence for purposes of picking up a known, Juvenile Victim-11 years of age. As the Victim arrived at the residence, the Accused became angry and was shouting at the Victim. The Accused discharged a firearm that he had been carrying in the direction of the Victim's vehicle as she made attempts to leave the area. This caused damage to the Victim's vehicle. Interviews were conducted and it was found that the Accused is a person who is not allowed to possess firearms. The Suspect had temporarily barricaded himself inside his residence which led to a Special Emergency Response Team call-out and the Accused was taken into custody without incident. The Suspect was arraigned before Magisterial District Judge Jeffrey C. MILLER and remanded to the custody of the Clarion County Jail following the incident. | |
