Crash Synopsis:

This crash occurred while unit #1 was traveling north on Quehanna High, Karthaus Twp., Clearfield County. While traveling north, operator #1 allegedly swerved to miss a deer. While doing so, unit #1 slid off of the roadway where it overturned and struck an embankment before coming to final rest on its wheels.

Subsequent investigation indicated that operator #1 was under the influence of alcohol.

A legal breath test confirmed that operator #1's blood alcohol concentration was over the legal limit.

Unit #1 suffered disabling damage and was towed from the scene.

Operator #1 was wearing a seat belt and not injured in the crash.
