Crash Synopsis:

This crash occurred as Unit 1 was traveling east in the right lane at mile marker 94, Washington Township, Jefferson County when the operator lost control of the vehicle. Unit 1 crossed over the left lane of travel, exited the northern portion of the roadway and struck the guardrail. Upon impact with the guardrail, Unit 1 traveled across both lanes of travel and came to final rest facing east on the berm. Unit 1 sustained damage to the left front axle and left side damage. Unit 1 was towed from the scene by Bigler Boys Towing.
