Crash Synopsis:

This crash occurred on Reynoldsville Falls Creek Rd. (SR. 950) approximately 290 feet north of its intersection with Sandy Valley Rd. This is in Winslow Twp. Jefferson County. At this location, Unit 1 was traveling north on Reynoldsville Falls Creek Rd. when Operator 1 lost control of Unit 1 on the snow covered road and crossed over into the south bound lane. Operator 1 continued off the south bound lane and struck a small embankment head on along the south bound lane. This impact caused Unit 1 to spin approximately 360 degrees and came to final rest facing south along the south bound lane of Reynoldsville Falls Creek Rd. Unit 1 sustained disabling front end damage. Operator 1 was suspected of being under the influence of alcohol and he was arrested for DUI. Charges are pending the results of Operator 1's blood results through MDJ Office 54-3-02. No injuries were sustained from the result of this crash. Unit 1 was towed from the

scene by Jewell's Towing.

Crash Synopsis:
