Crash Synopsis:

This crash occurred as Unit #1 was fleeing from a Pennsylvania Fish and Boat Commission Officer on Old Bethlehem Rd, Haycock Township, Bucks County, PA. It is relevant to note that the road conditions at the time which this crash occurred were snow-covered and slippery. Unit #1 left the roadway, and struck a mailbox on the right side of the roadway, traveled back onto the roadway, then struck a utility pole. Unit #1 sustained disabling damage to it's front end. The driver and passenger had visible suspected minor injuries. Unit #1 was towed from the scene by Swamp's Towing. Assisted on-scene by Pennsylvania Fish and Boat Commission.
