Crash Synopsis:

This crash occurred as Unit 1 was traveling east on Route 120, approximately 1.5 miles east Mason Run Road, Gibson Township, Cameron County, PA. Operator 1 related that she swerved right to miss a deer in the east bound lane causing her to strike the guide rail with the 1 o'clock position of unit 1. Operator 1 related that when she struck the guide rail it caused her car to spin and become perpendicular with the roadway. Unit 1 came to final rest on the right shoulder of the roadway. Unit 1 sustained disabling damage to the front and undercarriage. Unit 1 was towed from the scene by Ramsey's Garage. Operator 1 denied transport from Cameron County Ambulance. Operator 1 was wearing a safety belt at the time of the crash. PennDot was notified of the property damage to the guide rail.
