Crash Synopsis:

This crash occurred on Callicoon Rd., west of Bush Rd., Damascus Twp., Wayne County. At the location of this crash, Callicoon Rd. is a two lane divided highway comprised of an asphalt surface. Prior to this crash, Unit 1 was involved in a single vehicle crash which resulted in Unit 1 being ejected onto the roadway. Unit 2, being distracted by the other crash, Struck Unit 1 in the roadway. Unit 2 then left the scene. Operator 2 then returned to the scene shortly after. Unit 1 succumbed to his injuries after being struck by Unit 2.
