Crash Synopsis:

SYNOPSIS:

This single vehicle crash occurred on SR497 at its intersection with Krumstown Rd, Heidelberg Township, Lebanon County, Pennsylvania This crash occurred as Unit 1 was traveling East on SR 497, Operator 1 related he was traveling in the right travel lane and began turning left with the curve in the roadway. Unit 1 drove to fast for conditions which caused him to lose control. Unit 1 left the roadway and struck a utility pole on the left side off the roadway. Unit 1 sustained disabling damage to its rear driver side tire and rear bumper. Operator 1 related he was not injured as a result from this crash. Unit 1 was towed from the scene by Sheidy's Towing. Operator 1 was issued a citation PA VC 3361-(TA0538744-3)

INCIDENT DETAILS:

This fatal crash occurred as Unit 1, a tractor trailer, was traveling east on Woleber Road. Unit 1 began traveling downhill and approached a properly posted stop sign at the intersection of Woleber Road and Hilltop Road. The operator of Unit 1 failed to come to a complete stop at the properly posted stop sign on Woleber Road and continued to travel into the southbound lane of travel on Hilltop Road (SR 645). The operator of Unit 2 was traveling southbound on Hilltop Road at an unknown speed. The operator of Unit 2 was unable to observe Unit 1 enter the lane of travel due to there being a slight dip in the roadway. The operator of Unit 2 continued southbound on Hilltop Road and at the intersection with Woleber Road, the operator of Unit 2 struck Unit 1 at the 12 o'clock position. After impact, the operator of Unit 1 reversed his tractor trailer and parked in front of the properly posted stop sign. After impact, Unit 2 was facing south in the lane of travel. The operator of Unit 2 was not wearing his seat belt, which caused him to strike his rear-view mirror with his head. All airbags in Unit 2 were deployed. The operator of Unit 2 was not ejected from his vehicle and was found in the driver's seat. He was transported to Reading Hospital where he was later pronounced deceased due to his injuries. PSP Jonestown is investigating.
