Crash Synopsis:

This crash occurred on SR. 286 at its intersection with 1st. Ave., Glen Campbell Borough, Indiana County.

Operator #1 was attempting to enter SR 286 from 1st avenue to travel east on SR 286 and failed to yield for oncoming traffic. Unit #1 was subsequently struck by Unit #2 on SR 286.

Operator 1 sustained no known injuries, a passenger in Unit #1 sustained suspected serious injuries and was life flighted to Conemaugh Hospital Johnstown.

Operator 2 sustained suspected serious injuries and was transported to Punxsutawney Hospital and later transferred Altoona Hospital.
