Crash Synopsis:

On 09/20/2021 at approximately 1043 hours, Unit #1 was traveling East on Turner Road, Eldred Township, Jefferson County, PA. Operator # 1 was traveling at a unsafe speed for the roadway conditions when Operator #1 lost control of Unit#1 and impacted an Embankment on the Northern side of the roadway. Unit #1 then overturned onto its roof where it remained at its final rest position facing East. PSP Punxsutawney was notified and responded to the location.

Operator # 1 reported suspected minor injuries and was transported to Penn Highlands Brookville for precautionary measures.

PSP Punxsutawney responded to the location and were assisted on scene by Corsica Fire Department, Lead betters towing, and Pine Creek Township EMS.

Crash Synopsis:

This crash occurred on SR 219, in Bell Township, Clearfield County. Unit 1 was driving north on SR219 and attempted to turn left onto Bracken Road. Unit 1 failed to yield to Unit 2 as it approached it's position. Unit 2 was driving southbound on SR219. Unit 1 abruptly turned in front of Unit 2. Unit 2 attempted to avoid Unit 1, but was unable to enter the northbound lane due to on coming traffic. Unit 2 struck Unit 1 with its 1 o'clock position into Unit 1's 5 o'clock position. Unit 2 continued on SR219 for approximately 80 yards before pulling safely to the side of the roadway. Unit 1 came to final rest on Bracken Road. Units 1 and 2 sustained damage consistent with impact. Operator 2 did not report any injuries on scene. Operator 1 and Passenger 1 were transported to Penn Highlands Dubois as a precautionary measure. Both Operator 1 and Passenger 1 sustained minor injuries. Unit 2 was driven from the scene by Operator 2. Unit 1 was removed from the scene by Scott's Auto Towing. Mahaffey Volunteer Fire Department Assisted with traffic control.
