Crash Synopsis:

This single vehicle crash occurred as Unit 1 was traveling southbound on Pittsburgh-Buffalo Highway (SR119), Bell Township, Jefferson County. Unit 1 was traveling straight on a level surface, when Unit 1 left the roadway and struck an embankment, followed by entering back onto the roadway where Unit 1 again struck the embankment. Unit 1 came to final rest at the intersection of SR119 and Rock Run Road on the westbound berm, facing south.

Operator 1 sustained no injuries.

Unit 1 was towed from the scene.
