In the commission of this crime, Nathan HAMBURG - 25 of Schwenksville, assaulted and threatened his girlfriend from approximately 0600 hours on 02/24/24 until approximately 0855 hours when her mother arrived at her residence. Upon the mother's arrival, HAMBURG also threatened her and recklessly placed their lives and the lives of the couple's three children in danger when he began chasing after them in his truck and struck their vehicle with his in an attempt to run them off the roadway. Once he was able to stop their vehicle, HAMBURG also damaged the windshield of the victim's vehicle when he climbed onto the hood of her BMW X5 and smashed the windshield before fleeing the scene.
