Crash Synopsis:

The Pennsylvania State Police Franklin station investigated a hit and run crash that occurred within the parking lot of Wal-Mart located at 10 Kimberly Lane, Cranberry Township, Venango County, Pennsylvania. This area is a paved parking lot with painted yellow lines designating parking stalls. Unit 2 was parked within a marked parking stall facing west. Unit 1 struck Unit 2 at the 8 o' clock position where Unit 2 sustained a minor

scratch on the rear driver side door. Unit 1 then fled the scene in an unknown direction.
