**Crash Synopsis:**

**This crash occurred as Unit 1 and two were traveling North on Route 35 South, Lack Twp. Juniata County, PA. Unit 1 and 2 were traveling together, Unit 2 observed Deer crossing the roadway and applied the brakes abruptly. Unit 1 struck Unit 2 in the 6 o'clock position. Both Units were overturned and Operator 1, 2 and Passenger 1 were all injured in the crash. Assisting on scene were East Waterford Fire Company, Port Royal EMS and Lack/Tuscarora EMS. Gray's Towing removed the vehicles from the scene.**
