Crash Synopsis:

This crash occurred in the right lane of I 83 north, mile marker 48.4, Lower Paxton Township, Dauphin County. Unit 1 was behind Unit 2. Unit 2 suddenly slowed when the traffic in front slowed due to a disabled vehicle blocking the right lane. Operator 1 was following too close and struck the rear end of Unit 2 with the front end of Unit 1. Both vehicles came to a final rest at the point of impact.
