Crash Synopsis:

This crash occurred on 10/12/20 at approximately 1434 hours at the intersection of Pine Rd., and Mountainview Rd., South Middleton Twp., Cumberland County.

This single vehicle crash occurred as Unit 1 was traveling south on Mountainview Rd. Operator 1 failed to maintain control of Unit 1, traveled across Pine Rd., and struck a utility pole. Unit 1 sustained disabling damage to the vehicles front end (12 o'clock position). Unit 1 was towed from the scene by Triple K Fleet Services.

Operator 1 was wearing a seatbelt at the time of the crash. Passenger 1 was not wearing a seatbelt and
