8. INCIDENT DETAILS On 10/01/20, the Pennsylvania State Police- Vehicle Fraud Investigation Unit arrested the owner of El Camino Motors, Jeff Saidi. SAIDI was arrested for involvement in a fraud scheme to obtain PA registration plates using fraudulent driver's licenses and fraudulent insurance cards. SAIDI presented to customers that he was obtaining legitimate registration plates but they were obtained using fictitious drivers license, fictitious addresses and insurance cards. Inoscencio HERNANDEZ-SALVADOR was arrested and charged for involvement of obtaining PA registration plates using counterfeit documents at a tag agency effectively tampering records maintained by PennDOT. Jeff Saidi was charged with Corrupt Organizations, Deceptive Business Practices, Forgery, Insurance Fraud, Tampering with Public Records and other fraud related crimes. Inoscencio HERNANDEZ-SALVADOR was charged with Corrupt Organizations, Forgery, Tampering with Records, Identity Theft, Insurance Fraud and other fraud related crimes. SAIDI and HERNANDEZ-SALVADOR were arraigned and remanded to the Montgomery County Prison. This investigation was assisted by HSI & Norristown Police Department.
